# Administrative Guide for the 19<sup>th</sup> Annual General Meeting (19<sup>th</sup> AGM)

#### **Mode of Meeting**

D & O Green Technologies Berhad ("D&O" or "the Company") continues to leverage on technology to facilitate communications with its shareholders by allowing easier and more efficient access for them to attend the 19<sup>th</sup> AGM virtually through live streaming and Remote Participation and Electronic Voting ("RPV") facilities. The conduct of the virtual AGM is in line with the Guidance Note and FAQs on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia on 7 April 2022.

In addition, in line with Guidance Note 13.3 of the Malaysian Code on Corporate Governance, by conducting a virtual general meeting, this would promote greater shareholder participation as it facilitates electronic voting and remote shareholders' participation.

You may exercise your right as a shareholder of the Company to attend, participate (including pose questions to the Board/Management of the Company) and vote at the 19<sup>th</sup> AGM remotely by using the RPV facilities.

The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act, 2016 which requires the Chairperson of the meeting to be present at the main venue of the meeting. Shareholders WILL NOT BE ALLOWED to attend the 19<sup>th</sup> AGM in person at the Broadcast Venue on the day of the meeting.

# **Entitlement to participate in the AGM**

Only members whose names appear in the Record of Depositors of our Company as at 22 May 2023 shall be entitled to attend the AGM or appoint proxy(ies) to attend on his/her behalf

#### Remote Participation and Voting ("RPV")

As no shareholders should be physically present at the Broadcast Venue, we urge all shareholders to attend the 19<sup>th</sup>AGM remotely using the Remote Participation and Voting ("RPV") facilities which are available on Tricor Investor & Issuing House Services Sdn Bhd ("Tricor")'s digital platform, TIIH Online at <a href="https://tiih.online">https://tiih.online</a>.

Shareholders who appoint proxies to participate via RPV in the 19<sup>th</sup>AGM must ensure that the duly executed proxy forms are deposited in a hard copy form at the Registered Office of the Company situated at No. 15, Bukit Ledang, Off Jalan Duta, 50480 Kuala Lumpur ("Registered Office) or by electronic means to Tricor no later than Saturday, 27 May 2023 at 10.00 a.m.

Corporate representatives of corporate members must deposit their original certificate of appointment of corporate representative at the Registered Office to participate via RPV in the 19<sup>th</sup> AGM.

Attorneys appointed by power of attorney are to deposit their power of attorney at the Registered Office no later than Saturday, 27 May 2023 at 10.00 a.m. to participate via RPV in the AGM.

As the 19<sup>th</sup> AGM is a virtual AGM, members who are unable to participate in this AGM may appoint the Chairperson of the meeting as his/her proxy and indicate the voting instructions in the proxy form.

Procedures for RPV Shareholders/proxies/corporate representatives/attorneys who wish to participate at the 19<sup>th</sup> AGM remotely using the RPV are to follow the requirements and procedures as summarised below:

(f)	End of remote participation	Upon the announcement by the Chairperson on the Conclusion of the 19 <sup>th</sup> AGM, the Live Streaming will end.

## Note to users of the RPV facilities:

Should your registration for RPV be approved, we will make available to you the rights to join the live stream meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.

The quality of the live streaming is dependent on the bandwidth and stability of the internet connection at the location of the user and the computer.

## **Lodgement of Proxy Form:**

Since no shareholders/ proxy should be physically present at the Broadcast Venue, a Shareholder can appoint the Chairperson of the Meeting as his/her proxy and indicate the voting instruction in the Form of Proxy. The Form of Proxy must be deposited at the Registered Office of the Company situated at No. 15, Bukit Ledang, Off Jalan Duta, 50480 Kuala Lumpur, alternatively, you may also submit the Form of Proxy electronically, via TIIH Online at website <a href="https://tiih.online">https://tiih.online</a>, not less than forty-eight (48) hours before the time for holding the meeting or at any adjournment thereof, otherwise the instrument of proxy shall not be treated as valid. #### **Voting Procedure:**

- The voting at the 19<sup>th</sup> AGM will be conducted on a poll in accordance with Paragraph 8.29A of Bursa Malaysia Securities Berhad Main Market Listing Requirements. The Company has appointed Tricor Investor & Issuing House Services Sdn Bhd as Poll Administrator to conduct the poll by way of electronic voting ("e-voting") and Scrutineers Solution Sdn Bhd as Scrutineers to verify the poll results.
- Shareholders can proceed to vote on the resolutions and submit your votes at any time from the
  commencement of the 19<sup>th</sup> AGM on Monday, 29 May 2023 at 10.00 a.m. and before the end of the
  voting session which will be announced by the Chairperson of the meeting. Upon completion of the
  voting session for the 19<sup>th</sup> AGM, the Scrutineers will verify, and the Chairperson will declare whether
  the resolutions are duly passed.
